K-12 Family Multi-Sibling Discount & Tuition Assistance: applied in the following order:

1. Family Multi-Sibling Discount: applied equally to each child
 - 15% discount progressively per child is applied to family total tuition
 - Oldest child is considered to be first child; next oldest is second child, etc.
2. Tuition Assistance: School Choice Voucher, State Tax Credit Scholarship

YOU MAY CHOOSE ONE OF THE FOLLOWING TUITION PAYMENT OPTIONS:

1. **ENTIRE YEAR'S TUITION** - Due on or before **July 29th**. Paid directly to BCS. **Deduct 1% from total tuition.**
2. Utilizing **FACTS Tuition Management (\$40 fee)** you may authorize one of the following methods of automatic debit from your checking or savings account on the 5th or the 20th of the month:
 - a. **2 Installments** – First payment is due in July and the second payment is due in January
 - b. **11 MONTHLY Installments** – (July through May)

TUITION PAYMENT POLICIES

1. Any account that pays tuition in installments throughout the year (see option a. and b. on opposite side) will use the service of FACTS Tuition Management for automatic debit from the account of your choice.
2. In the case of a missed FACTS payment, a \$30 FACTS Missed Payment Fee will be automatically deducted within 20 days of the payment date. Missed payment fees are payable to FACTS for each payment attempt that is missed and any missed FACTS fees will be reattempted. NSF fees from your bank may also be incurred.
3. Any changes to your FACTS account are made through the school. If you need to change information such as address, phone number, email address or banking information, contact the BCS Financial Secretary in the High School Office.
4. If there is a need to change the payment date or payment amount, you must contact the Financial Secretary who will notify FACTS if any changes are to be made. **ALL** changes must be received by FACTS at least **five (5) business days prior to the payment date** in order to affect the upcoming payment.
5. An account becomes delinquent with three attempted and failed FACTS payments. Delinquent accounts may cause a student to be removed from school unless the parents agree to written alternative arrangements as deemed appropriate by Administration.
6. School records including report cards and transcripts may be withheld for any student with a delinquent account. Students with outstanding tuition balances will not be allowed to graduate from BCS without consent of the Finance Committee.
7. The Curriculum Fee is non-refundable.
8. If a student enters school after the first two weeks of the new school year, tuition is assessed for the actual days enrolled. However, the Curriculum Fee is not prorated.
9. If a student withdraws from school after the first FACTS payment has been deducted but within the first two weeks of school starting, the \$40 FACTS fee and the amount for the Curriculum Fee will be deducted from the amount of the FACTS payment(s) to be refunded.
10. If a student withdraws from school after the second week of the new school year, tuition is assessed for the actual days enrolled. The parents will be responsible for paying any outstanding fees.
